## **Need to Be Fingerprinted to Work as a School Employee in a School System?**

Effective July 1, 1994, Public Act 94-221 requires that all newly hired employees of school districts be fingerprinted for a criminal history check, regardless of their position. Certified and classified staff must be re-fingerprinted each time they change school districts.

## **How Can EDUCATION CONNECTION Assist You?**

EDUCATION CONNECTION will process and forward your fingerprints and remittance to the proper state and federal authorities for a criminal history check, and notify the districts in EDUCATION CONNECTION's area, by which you have been hired, that you have been fingerprinted.

Once received, EDUCATION CONNECTION will inform the district of the results of your criminal history check only when a problem exists.

## What You Need to Do

- Call EDUCATION CONNECTION:
  - If you would like to make an appointment to be fingerprinted in Litchfield, call the Litchfield office at 860.567.0863.
  - If you would like to make an appointment to be fingerprinted in Danbury, call the Danbury office at 203.791.1904.
- Bring with you:
  - Fingerprint Requisition Form (located on the back of this brochure);
  - Cashier's (Bank) Check or Money Order in the amount of \$43.25, made payable to EDUCATION CONNECTION; and,
  - Information regarding your social security number, photo ID, & date and place of birth.

## DIRECTIONS

### LITCHFIELD OFFICE: 355 GOSHEN ROAD

#### From the North or South

Take Route 8 to Exit 42 (Route 118 west). Go 5 miles to Route 202 in Litchfield. Continue west on Route 202 for another 2/10 of a mile. Turn right onto Route 63 north. Go 1-4/10 mile; EDUCATION CONNECTION is on the left.



#### From the West

Take Route 202 to Litchfield. Turn left onto Route 63 north. Go 1-4/10 mile; EDUCATION CONNECTION is on the left.

#### From the East (Hartford)

Take I-84 to Exit 39 (Farmington). Follow Route 4 west through Farmington, Unionville, Burlington, and Harwinton. Follow Route 118 west, going straight through the stop light at the Catholic Church in Harwinton. Go 5 miles to Route 202 in Litchfield. Continue west on Route 202 for another 2/10 of a mile. Turn right onto Route 63 north. Go 1-4/10 mile; EDUCATION CONNECTION is on the left.



### DANBURY OFFICE: 345 MAIN STREET

#### From the East

Follow I-84 west to Exit 5.

Take a right off the ramp onto

Main Street. Go through three traffic lights. EDUCATION CONNECTION is on the left.

#### From the West

Follow I-84 east to Exit 5. Continue straight past the stop sign to the bottom of the hill. At the light, take a right onto Main Street. Go through two traffic lights. EDUCATION CONNECTION is on the left.

Connecticut law requires local school systems to have all new employees, including substitute, temporary, and per-diem employees, fingerprinted as a condition of employment. Therefore, you can make an appointment at EDUCATION CONNECTION to be fingerprinted by following the instructions listed in this brochure.

Please bring this form and **BANK CHECK or POSTAL MONEY ORDER made payable to EDUCATION CONNECTION** in the amount of **\$43.25**. If fingerprint confirmation is to be sent to districts outside of our membership area, please include an additional \$1.00 per district to cover additional expenses. Be prepared to supply a photo ID, your social security number, & your date and place of birth. **CASH or PERSONAL CHECKS WILL NOT BE ACCEPTED.**
